Dear friends,

## MINUTES FROM WAVA COUNCIL MEETING IN MIYAZAKI, JAPAN, MAY 21 - 25, 1992

<u>Present</u>: Cesare Beccalli (chair), Robert G. Fine, Bill Taylor Jacques Serruys, Al Sheahen, Bridget Cushen, César Moreno Bravo, Don Farquharson (from item 3), Pascal Mouassiposso Mackonguy, Hari Chandra, Hans Axmann, Brian Oxley (up to item 23), Jim Blair, José Figueras and Torsten Carlius (secretary)

## 1. Opening of the Council meeting

The President Cesare Beccalli welcomes all the Council members and states that the meeting will cover many items. He addresses a special warm welcome to César Moreno as the IAAF Representative on the WAVA Council as well as to Brian Oxley, the new North and Central American Representative.

## 2. Approval of the agenda

The proposed and beforehand distributed agenda for the Council meeting is approved.

### 3. Report from meeting with the Organizing Advisory Committee

Robert G. Fine, the OAC President, reports from yesterday's meeting. The OAC has agreed upon the following for next year's World Veterans' Championships (WVC) in Miyazaki:

- x WAVA shall control the whole arrangement
- x The opening ceremony will be short with no entry for the participants, flags and country names carried by officials and short speeches
- x The closing ceremony will have entry of all participants in age-groups, flags and country names carried by officials
- x For the meetings simultaneous interpretation is desirable. Regional meetings, WAVA committee meetings and women's meeting are scheduled for one day at the beginning of the Championships with the General Assembly some days later. Team captains will have a short meeting every day in the morning.
- x The banquet is proposed for the second last day, i.e. the evening before the maraton
- x The Japanese have assigned all accomodation to one travel agency in Japan (Kinki Nippon Tourist Co) which is not acceptable. WAVA wants one contact within the organizing committee that can work together with the travel agencies that the Affiliates of WAVA normally use.
- x The OAC has tried to work out a frame schedule for WVC that can be used with minor adjustments by all future organizers. Similar events are separated to make participation in all possible. The weight pentathlon is not approved by the General Assembly but is included in the programme as an extra event. WAVA should have a proposal at the next General Assembly to make the weight pentathlon part of the regular WVC programme.

The frame schedule is approved by the Council but the technichal committee appointed for this Council meeting must solve the problem with trials/final or seeds for 5.000 meters. The Council votes informally 7 votes for trials/final and 6 votes for seeds. 1 abstention.

x It is noted that the Govenor of Miyazaki has promised to supply proper accomodation for all participants and other visitors.

The Council discusses the possible necessity of introducing some limits for participation at the WVC. One opinion is to reduce the number of events, for example can the cross-country be staged at some other place/time. A standard schedule could be of some help to limit participation.

The pentathion is discussed but the question is left to the technical committee to decide but the Council's interest is very limited.

A proposal to stage age-grading 100 meters the last day is defeated by 6 votes against 4 votes with 4 abstentions.

### 4. Constitution and By-Laws

With Torsten Carlius in the chair the Council goes through the WAVA Constitution and By-Laws up-dated with amendments and additions decided at the General Assembly in Turku last summer.

At this item decisions are taken about new amendments to the Constitution to be proposed by the Council to the next General Assembly in 1993 – see enclosure.

### 5. IAAF/WAVA relationships

Cesare Beccalli describes the agreement with IAAF that has been worked out principally between him, César Moreno and the IAAF President, Dr Primo Nebiolo. The agreement implies an economic support to WAVA of US Dollars 15.000:- a year in 1992 and 1993 directly paid to WAVA and a further support of US Dollars 25.000:- a year in 1992 and 1993 to cover expenses for WAVA work at the IAAF Office (travels, the WAVA Handbook etc). The relations with IAAF are very good with mutual respect for each other. Mark Horley has been appointed WAVA's contact in London. WAVA has also possibilities to use the IAAF information channels. César Moreno uses the moment to express his pleasure to be here and his ambition to really be one of the WAVA Council members. He presents the formal agreement with IAAF from January 31, 1992, with the addition made by Dr Primo Nebiolo that the expenses at the IAAF office must not exceed US Dollars 25.000:- a year.

By this economic support the WAVA Affiliates will not have to pay annual affiliation fee to WAVA. The WAVA regions will get part of the IAAF support as compensation for removed membership fees.

All articles in the IAAF magazines/information letters on WAVA matters should go trough the WAVA secretary.

The Council expresses its great appreciation over the agreement with IAAF and means that it will further develope the relations between the 2 organizations.

#### 6. Sponsors

Cesare Beccalli presents an idea to sponsorship from Mondo Rubber, a company that has laid the athletic tracks for Seoul/Barcelona They are interested to buy one page in the WAVA handbook for US Dollars 5.000:- on a strictly commercial basis and will pay WAVA a further US Dollars 15.000:- if they get the contract for the new stadium in Miyazaki. There is no obligation from WAVA that Mondo wins the contract and because of that WAVA does not want to have a special percentage of the contract amount.

Cesare Beccalli also promises to help to ask Mondo if there are possibilities to support also the WAVA regions with small advertisments.

For future sponsorships the Council decides that the President, the General Secretary and the proposer shall decide in the individual case.

After this decision the Council meets with 3 representatives for Mondo Rubber to confirm the agreement.

### 7. Treasurer's report

The Treasurer presents his réport for the period January 1 through May 15, 1992. Total revenues for the period are US Doll. 1.255:22 and total expenses US Dollars 12.775:23 which makes a deficit of US Dollars 11.520:01. Future revenues will bring the result to a surplus

The report is approved.

#### 8. Budget 1992-93

The Treasurer presents his budget proposal for 1992-93. It has to be redrafted with respect to the IAAF support, the agreement with Mondo and the need to increase some administrative expenses.

The Council decides to raise the daily allowances for the Council members from 35 to 40 US Dollars a day from 1993. In this connection the Council makes an informal vote as to its accomodation during the WVC in 1993. 8 votes are given for a hotel down-town in Miyazaki and 7 votes for the present Sun Hotel.

The information channels for WAVA are discussed and the Council decides to keep the present liasion with "National Masters News" up to the next Council meeting but Cesare Beccalli/César Moreno/ Torsten Carlius are commissioned to look into how WAVA could use the IAAF information channels.

The point is also raised that NMW shall remove the word "official" when describing its relations with WAVA in the magazine as this is not correct and could create difficult legal situations for both parts.

The Council decides further to delete section 8 in the By-Laws (Expenses of the Council) that state that, if possible, part or all of the expenses of the Regional Delegates shall be paid by WAVA. All Council members shall from now on economically be treated equally.

A new budget proposal for 1992-93 is presented later during the Council meeting. This shows revenues of US Dollars 139.000:- and expenses of US Dollars 108.600:- and consequently a surplus of US Dollars 30.400:-. The Council ratifies this proposal as the WAVA Budget 1992-93.

Finally Cesare Beccalli proposes how to use the annual support of US Dollars 25.000:- at the IAAF office:

This can only be an outline as we cannot to-day foresee exactly how WAVA best can use the money.

The regional delegates are requested to apportion US Doll. 16.000 between the regions. They come back later during the meeting with the following proposal: **1992 1993**

which is ratified by the Council for 1992-93.

Jim Blair expresses his gratitude for the good job that is made by the Treasurer as well as by Cesare Beccalli/César Moreno.

### 9. WAVA Trust Fund

It is commissioned to the President and all other Council members to try to find donators for a WAVA Trust Fund which could be of great help for WAVA in the future.

## 10. WAVA flag and logo

Cesare Beccalli presents a proposal for new WAVA flag made by Mr Missoni, Italy. After intense discussion the Council decides with 12 votes against 1 vote and 2 abstentions to accept the proposal. Jim Blair and Jacques Serruys are commissioned to have the flag produced as soon as possible. The logo on the stationery must be different from the flag as this shall also have the IAAF symbol. Cesare Beccalli has made out a letterhead which is approved by 13 votes against 1 vote and 1 abstention.

### 11. Recommendations to amendments of Constitution

The recommendations to amendments of the WAVA Constitution approved by the Council to be presented to the the next General Assembly are in enclosure to these minutes.

The following proposals are defeated:

- a) Amendments to the WAVA Constitution can only be made every four years.
  - No: 8 votes Yes: 4 votes Abstentions: 3
- b) To be allowed to have delegates at the WAVA General Assembly a country must be represented at the competitions.
  No: 8 votes Yes: 5 votes Abstentions: 1

### 12. Handbook

The Council decides to print the new WAVA Handbook as follows:

<u>Messages</u>	English and French
Constitution	English, French, German, Italian and Spanish
By-Laws	English, French, German, Italian and Spanish
History	English

The Handbook will be printed with the new WAVA/IAAF logo and a photo of the Sports Park in Miyazaki on the front page. The world records as of April 15, 1992, and information about hurdles and implements will be added in appendixes.

## 13. Biddings for next World Veterans' Championships

a) Stadia

It is reported by Cesare Beccalli that Singapore has announced that they cannot stage the next WVC in 1995. Later there has been discussions that might lead to that Singapore can reconsider their rejection. César Moreno will talk with Maurice R. Nicholas at the IAAF Council meeting the next week.

Some preliminary talks have been conducted by letter with South Africa but this country is to-day not an IAAF Affiliate and must be reinstated as such before any real negotiations can start.

If Singapore does not change its rejection and if South Africa is not reinstated as IAAF Affiliate there is interest to bid from Chile and Great Britain. The 2 countries have plans for 1997 but will discuss at home if they can bid already for 1995. Cesare Beccalli asks all the Council members to cooperate to find organizers for 1995. For 1997 there is interest from Chile but if the last two championships have been in Japan and Singapore there can arise opposition against Chile for 1997 depending on long travel distances 3 WVC in succession for most of the participants.

Jim Blair suggests that the WVC shall alternate between the 6 regions according to an established plan.

The regions know their turn, it will be easier to plan. Such a plan could be introduced after 1997. No decision is taken but Jim Blair urges the Council member to think it over for a possible future decision.

#### b) Non-Stadia

There are no formal biddings for 1994 or 1996. Some rumours have been heard but no contacts are made so far.

The Council members and the Non-Stadia Committee members present in Birmingham are commissioned to open discussions at the Non-Stadia WVC in Birmingham in August this year.

Due to the fact that the General Assembly, which is held only in odd-numbered years, shall sanction each WVC there could be reason to find another way to sanction the Non-Stadia WVC. One year ahead is a too short and three years can be a too long period. No decision is taken on this issue.

#### 14. Drug testing

Cesare Beccalli and César Moreno account for their discussions with the IAAF Doping Commission. César Moreno also reads a letter from Arne Ljungqvist which confirms that IAAF does not insist upon drug testing in Miyazaki but leaves the matter entirely to WAVA. If WAVA wants drug testing it must be at WAVA's expense and must follow certain procedures. The Council feels the need for a WAVA Doping Committee to advice the Council and supervise WAVA's activities in this area.

The Council decides to institute a WAVA Doping Committee consisting of 3 persons nominated by the President. The Women's Representative shall be one of the Committee members. For the period to the next General Assembly the President elects Robert G. Fine (chair), Bridget Cushen and César Moreno with Hans Axmann as deputy. The rules for the Doping Committee are included in the By-Laws at present but will be brought to the next General Assembly for making the committee constitutionally a standing committee.

The Council decides to have drug tests in Miyazaki (14 members in favour and 1 abstention).

## 15. Affiliates

Torsten Carlius accounts for the present situation which is:

a) 4 new Affiliates have been approved by the President and the Secretary in accordance with the Constitution, i.e.: Estonia, Latvia, Lithuania and American Samoa.

They have made correct applications and the Secretary has informed the resp. Regional Delegate.

The Council confirms unanimously these affiliations.

 b) Applications have been received from but no action has so far been taken: Kenya, Senegal, Mauritania, Nauru, Gambia and CIS.

The Council decides to accept these countries as WAVA Affiliates and the Secretary will confirm the affiliation with copy to the resp. Regional Delegate.

c) Other countries that want to be affiliated with WAVA are South Africa and Yugoslavia. To-day's situation cannot make this possible and WAVA awaits the development before decision.

It is intended to make a circular to IAAF Affiliates and offer WAVA Affiliation to all those whose country is not WAVA Affiliate. The Secretary deals with this according to the WAVA Constitution with the following restriction decided by the Council:

Prior to October 7, 1993, if the President and Secretary feel that an application for WAVA Affiliation is proper, they have the authority to approve of same. If the President and Secretary feel that there is a problem in the application, the matter will be referred to the appropriate Regional Delegate. Thereafter the Council will take a vote by mail on the application.

### 16. Special questions

The Council discusses the situation in some countries:

- **Peru** The situation with two associations is now solved so that there is one veterans association that is recognized by the NGB.
  - India There are still two associations that clash with each other. WAVA has recognized All India Veterans Athletic Association as its Affiliate. In India there have been attempts to unify the 2 associations into one but without success. The NGB recognizes the WAVA Affiliate and arranged a common meeting in February, 1992, to make final elections for one body but the other association did not attend this meeting. For the moment the situation is not solved and the WAVA Council cannot do much about it but wait and see.

It is obvious that only entries through the IVAF can be accepted for the WVC in Miyazaki.

South Africa This country will probably very soon be reinstated by IAAF and is then welcome as WAVA Affiliate.

### 17. Determining the age group

There has been some misunderstanding in some countries as to determining the age group resulting from rule 102 in the IAAF handbook. WAVA states that date of birth is the valid principle but IAAF has year of birth in rule 102. The IAAF Office and César Moreno in his capacity of chairman of the IAAF Veterans Committee have written to the country most concerned, i.e. Belgium, but the NGB has so far refused to accept the WAVA rules.

Cesare Beccalli states that a country can very well have their own rules on a national basis but as soon as the meeting is international the WAVA rules shall be followed. Cesare Beccalli promises to see to it that a letter with these contents is sent to Belgium and other countries with similar problems.

As IAAF cannot change its rules until the next General Assembly in 1993 the temporary solution of the problem could be an addition to the IAAF rule 102 that WAVA rules shall be valid at veterans meetings all over the world. Cesare Beccalli promises to talk with the IAAF General Secretary to clarify the matter.

### **18. WAVA Committees**

The Secretary has observed that the members of WAVA Committees are not nominated by the President as the Constitution prescribes. Furthermore there is not at hand a complete list of the WAVA Committee members. The Secretary is commissioned to put together the necessary information as soon as possible for the President's confirmation.

### 19. Multi-event scoring/Age grading/Weight pentathion

The Stadia Vice-President Bill Taylor reports that the work on multi-event scoringtable and age grading factors is not yet ready.

After discussions it is decided that the Stadia Committee puts forward proposals to scoring table (with appendix for weight pentathion) and age grading factors not later than September 30, 1992, whereafter the Council will vote by mail.

The Council further decides (14 yes and 1 abstention) to include the weight pentathlon in the WVC programme provided that the ordinary pentathlon is excluded. For 1993 the weight pentathlon will be an unofficial event as it is not stipulated in the contract.

#### 20. Birmingham 1992 - road-running championships

The Non-Stadia Vice-President Jacques Serruys reports that there are at present about 1.500 entries for the 1st Road-running World Veterans' Championships in Birmingham. The expected figure is 4.000 entries. During the championships the Non-Stadia Committee will meet and they will probably come forward with a proposal to enlarge the programme - possibly also transfer of some event from the Stadia programme.

Bridget Cushen reports that there is no head sponsor for this championship. The WAVA fee is questioned but is now accepted. The fee is included in the contract with WAVA.

### 21. Presentation of regional reports

The Regional Delegates present and comment upon their written reports. In most regions the veterans athletics are developing very strong with only minor problems. Regional Championships will be arranged in all regions in 1992 except Africa. In this context Bridget Cushen mentions that 1993 will in Europe be called the Year of the Elderly and that a meeting commemorating this will be staged in France.

Pascal Mouassiposso reports that the South Africa question has been discussed on April 25 at the Unity Games in South Africa. All expect that South Africa will be reinstated by IAAF very soon and it will thereby also be an WAVA Affiliate. At the African Athletics congress in Cairo information was given about the veterans' activities and it was decided to form an African committee for veterans' athletics. This will be done at the African Championships this year in Mauretania. The Council expresses its delight at this developement.

For Europe Hans Axmann has a special report over the situation in the former Sovjet Union. The country will this year compete as CIS (Commonwealth of Independent States) and will be approved by IAAF as such for 1992. Thereafter it is expected that the individual countries will apply for affiliation as have the Baltic States.

### 22. Council nominations for 1993 elections

The Council votes for its nominations to the General Assembly elections in 1993 with the following results:

#### 23. General Assembly 1993

The Councils decides to arrange the Genneral Assembly in 1993 in the same way and with the same system as in Turku. Simultaneous interpretation is desirable but could cost too much. The organizers in Miyazaki look into the possibilities and costs and will come back.

The Council decides to commission Robert G. Fine, Al Sheahen and Torsten Carlius to arrange the General Assembly. Each region is welcome to elect one representative on this committee.

The Council decides with 11 yes-votes and 3 abstentions to have the banquet on October 17 after the Closing Ceremony.

### 24. Auditors

The Council elects as auditors up to the General Assembly in 1993: Giuseppe Galfetti, Switzerland, and Jack Loman, Canada

### 25. Legal form of WAVA

Jim Blair raises the question of WAVA's legal form and means that WAVA should be an Incorporated Society. Cesare Beccalli will look into the matter and come back. It is possible that a committee must be formed to look into this question as well as the insurance/liability need.

### 26. Closing of the Council meeting

The President thanks the Council members for their attention and interest and declares the Council meeting closed.

## RECOMMENDATIONS AT THE WAVA COUNCIL MEETING IN MIYAZAKI, JAPAN, MAY 2I-25, 1992, ABOUT AMENDMENTS TO THE WAVA CONSTITUTION TO BE PRESENTED TO THE WAVA GENERAL ASSEMBLY IN 1993.

### 1. General Assembly, section 4

Addition to paragraph 4 D

After the words " simple majority vote" on line 2 is added: , except for amendments to the Constitution for which a 2/3 majority shall be required. Decisions shall ...... Approved unanimously.

### 2. General Assembly, section 4

New sentence is added to paragraph 4 H.

If an constitutional amendment is defeated at a General Assembly a similar cannot be raised at the next General Assembly again. Approved by 14 votes against 1.

### 3. General Assembly, section 4

New paragraph is added as 4 J

Anyone found guilty of any offence under sub-section 7.1 in the By-Laws may not be a delegate at WAVA General Assembly during the suspension period. Approved by 13 votes against 1 and 1 abstention.

### 4. General Assembly, section 4

New paragraph is added as 4 K (taken temporarily into the By-Laws under paragraph 8.1)

Substitutes for Regional Delegates will be permitted upon written verification from the Regional President submitted to the WAVA General Secretary 24 hours in advance of the opening of General Assemblies and Council meetings. Approved unanimously.

### 5. General Assembly, section 4

New paragraph is added as 4 L (taken temporarily into the By-Laws as 8.3)

Each delegate of an Affiliate shall be a member of the Affiliate. Substitutes may be named for any delegate, with the exception of a WAVA Officer. A substitute may vote in the place of an absent delegate provided the substitute meets all required qualifications of a voting delegate. Substitutes shall be stated upon written verification from the President of the respective Governing Body on the stationery of that National Body submitted to the WAVA General Secretary 24 hours in advance of the opening of the General Assembly. There shall be no voting by proxy. Approved by 14 votes against 1.

#### 6. Council, section 5

The last words on line 3 of paragrapf 5 F shall read:

"a quorum shall consist of nine members." Approved by 14 votes against 1 vote

### 7. Women's Assembly, section 8

The following words are deleted in paragraph 8 B, line 2

"and may vote" Approved unanimously

### 8. Standing Committees, section 9

The following committees are added as standing committees:

- Organizing Advisory Committee
- Law and Legislation Committee
- Doping Committee

For the time being these committees are included and described in the By-Laws.



### REPORT FROM THE WAVA COUNCIL MEETING IN MIYAZAKI, JAPAN,

## MAY 21 - 25, 1992

The WAVA Council met in Miyazaki, Japan, May 21-25, 1992 and had during these days also the opportunity to visit the facilities for next year's World Veterans' Championships. The unanimous impression is that our hosts will offer all athletes and visitors the best possible conditions. A new track will be built and the whole meeting will be held in the Sports Park of Miyazaki. We are really looking forward to the 1993 World Veterans' Championships with great expectations and are sure they will be realized.

The Council meeting covered a lot of items and I will here below concentrate the report on those of common interest.

### WAVA/IAAF Relations

Since the General Assembly in Turku last summer there has been a lot of work to develope the relations between WAVA and IAAF and from our President's report to the Council it was understood that this work has been very successful. IAAF has appointed a member to the WAVA Council and Cesare Beccalli could warmly welcome César Moreno, Mexico, as this IAAF representative. César Moreno is also President of the IAAF Veterans' Committee and will from this position further contribute to the developement of the WAVA/IAAF relations.

The practical result so far is that IAAF supports WAVA by an annua economic amount and by services at the IAAF Office in London. WAVA will in 1992 and 1993 receive US Dollars 15.000:- a year of which 8.000:- a year will be given to the regions for their work. This also means that WAVA will not demand an affiliation fee from the Affiliates. The support from IAAF will cover this income for WAVA and the regions are likewise expected to cancel their fees.

The annual US Dollars 25.000:- will be used to cover services for WAVA by the IAAF Office in London, President's and Secretary's travelling, printing & distribution of our new handbook and so on. At present Mark Horley is our liasion person in London. WAVA can also use the IAAF publications for own information and messages.

#### Handbook

The new WAVA handbook is ready for printing very soon. After the General Assembly there has been much work to make all additions and amendments. This handbook will also have the Constitution and the By-Laws in 5 languages, i.e. English, French, German, Italian and Spanish. We expect to distribute the handbook to all WAVA Affiliates no later than October this year.

### Budget 1992/1993

The Council ratified the budget for 1992/1993. The income amounts to US Dollars 139.000:- and the expenses to US Dollars 108.800:-. The surplus is thus budgeted to US Dollars 30.200:- which means that there should be room enough to meet unforeseen events.

### WAVA flag and logo

The need for a new - and bigger - WAVA flag has been felt for a long time. Cesare Beccalli presented a proposal for the new flag and a proposal for new logo on the WAVA stationery. Both were accepted by the Council and the letterhead is the one used on the first page of this report. The flag will be presented in Miyazaki.

### Council nominations for 1993 elections

According to the Constitution the Council has to nominate its candidates for the Council offices to be elected at the next General Assembly. Therewere practically no discussions and the voting resulted as follows:

In due time all Affiliates will be informed about the General Assembly time-table and the dates for making their proposals.

### Drugtesting

The Council decided unanimously with 1 abstention to have drug tests in Miyazaki. For this purpose the IAAF will help and their rules shall be followed. The WAVA Council decided to institute an own WAVA Doping Committee to advise the Council and supervise the activities in this area.

This WAVA Doping Committee is chaired by Robert G. Fine and members are Bridget Cushen and César Moreno with Hans Axmann as deputy.

### WAVA Affiliates

have/

The WAVA family grows continually but we so far only about 90 Affiliates. It is intended to make a circular to IAAF Affiliates and offer WAVA affiliation to all those countries that to-day are not WAVA Affiliates. This invitation will be distributed during the autumn.

The General Assembly in Turku decided on the proceeding for WAVA affiliation and the constitutional rules will of course be strictly observed.

#### Auditors

The Council has according to the Constitution to elect 2 auditors for the time to the next General Assembly. The Council elected for 1992/1993:

Giuseppe Galfetti, Switzerland, and Jack Loman, Canada

Both are well-known veterans to most of us and will surely make a good and competent job.

### Stadia Championships in 1995

At the Council meeting it was reported that Singapore had plans to withdraw as organizers of the World Veterans' Championships in 1995. It has later been confirmed and at the moment discussions are going on with some possible organizers. Anyone interested to stage these championships are welcome to contact the WAVA Secretary or Executive Vice-President Robert G. Fine.

### Non-Stadia Championships in 1994 and 1996

There are no formal bids for 1994 or 1996 even if some rumours have been heard from two or three Affiliates that they are interested to stage these championships. The Non-Stadia Committee will meet in Birmingham in August at this year's championships and will try to open more concrete discussions. Also here are interested countries welcome to present their bid either to the WAVA Secretary or to the Vice-President Non-Stadia Jacques Serruys.

The Council has also noted that the present form for sanctionning the Non-Stadia Championships is not satisfactory. The Constitution prescribes that this is a matter for the General Assembly but this is held in odd-numbered years while the WVC Non-Stadia are held even-numbered years. This means that a period of one year can be a too short period and a period of three years a too long period. The point will be discussed by the Non-Stadia Committee who also will have a discussion on the programme at the WVC Non-Stadia.

### IAAF rule 102

There has lately been some confusion about how the age group shall be determined. The WAVA General Assembly in Turku decided that date of birth is the valid principle but IAAF has in its rule 102 the year of birth. The overall agreement between WAVA and IAAF says that WAVA shall make the rules for veterans' competition and this means that the WAVA rule shall be followed - in any case in all international meetings.

Cesare Beccalli and César Moreno will try to work out a temporary solution to this problem until both WAVA and IAAF has the same wording. Also for IAAF is this a matter for the General Assembly.

### Multi-event scoring/age grading factors

The work on multi-event scoring and age grading factors was unfortunately not finished in time for Miyazaki. The time limit for the 2 sub-groups was extended to September 30, 1992, and the WAVA Council will then take its decision.
