MEET FORMAT: The "Masters Indoor Open" will be held in conjunction with the "USATF National Masters Heptathlon Championships" (for men and women). A separate form is required for entry into the Heptathlon.

**MASTERS INDOOR OPEN** 

- **TRACK SITE:** Hillside is located a few minutes west of downtown Chicago. Proviso West is just east of 1-294/the Tri-State, at the southeast intersection of Wolf Road and Harrison Street. Harrison Street is the first street south of 1-290/the Eisenhower Expressway. From the Eisenhower, exit south on Mannheim (Highway 12 and 45) to Harrison, then west to Proviso West. From the north on the Tri-State, exit east on Cernak/22<sup>nd</sup> Street. From the south on the Tri-State, exit east on Roosevelt Road. From Cernak or Roosevelt, continue east to Wolf Road, then north to Proviso West.
- TRACK FACILITY: Proviso West High School has an outstanding indoor track facility: Mondo Super X surface, inside rail on curves, six 42-inch lanes, two nine-lane 55-meter straight-aways, double long jump/triple jump runways, two high jump pits, and separate shot area. Seating capacity goes up to 2000 in the balcony.
- SANCTION: Illinois Association of USA Track and Field. HOST: USATF Illinois and Midwest Masters Track and Field Club.
- USATF REQUIREMENTS: 1998 USA Track and Field memberships are <u>required</u> of all athletes, \$15.00 (\$20.00 for entries postmarked after March 25, 1998). A membership form and fee (with separate check number) may be submitted in lieu of a 1998 membership number.
- ENTRY FEES/DEADLINES: \$10.00 for the first event, \$5.00 for each additional event, or \$25.00 for an unlimited number of events \$10.00 extra (flat fee) for entries <u>postmarked</u> after Wednesday, March 25. No entries will be accepted on meet days. \$5.00 for each event <u>change</u> will be charged on the day of the meet (no guarantee that change will be accepted). No changes will be accepted by phone or fax.
- ENTRY CONFIRMATION: If your complete entries are <u>received</u> by March 28, and if you have enclosed a self-addressed stamped envelope, we will mail you a confirmation. We will not confirm receipt of your entries by phone or fax.

- AWARDS: Masters National Open awards to the first place finisher in each event/in each age division (30-34 through 90over). Plus, age-graded apparel/product awards to the top age-graded finishers in each event (all age divisions combined).
- FACILITIES: Parking is available in the south lot of Proviso West High School, adjacent to Field House/Track. Restrooms and dressing rooms are available. Concessions on site.

ADMISSION: \$3.00 per day for non-athlete adults, \$1.00 for students. Pre-school admitted free.

#### SCHEDULE OF EVENTS

Heptathlon events are listed here for information only. Heptathlon event scheduling will take precedence on both April 4 and 5. Heptathlon athletes will have a minimum of ½ hour between events.

Special Event: A "Mini-Multi" competition will also be held – to consist of any three events listed for the Masters Open (Heptathlon events may not be used to score for the MM). The "Mini-Multi" competition will be automatically scored only for athletes who specifically sign up/enter this competition (MM) on the Entry Form. No extra fee is required for the MM, if the entry form and fees are received <u>prior</u> to April 4-5. However, athletes may designate three of the events they entered prior to the meet as their MM entry on April 4 or 5 for \$5.00 extra.
