

Dear Laetitia:

Thank you for your faxes of 20 May. I apologize for not responding sooner. I have been out of town.

- 1) Thank you for acknowledging our invoice for US\$20,000. It has not yet been credited to our account, but I know it will be soon.
- 2) Re your invoice to WAVA for air fare for Cesar Moreno Bravo to the WAVA Council meeting in Durban, South Africa, we have a problem.

It is true that WAVA pays the air fare expenses of each Council member to the annual WAVA Council meetings. In the past, Cesar Moreno Bravo has not submitted an invoice for his trips, so I assumed the IAAF was picking up his tab, which we appreciated.

We would be happy to pay his air fare to Durban, but we are limited by our by-laws to paying only "the lowest air fare reasonably available." The 39,913 French francs you request amounts to about US\$7635, based on today's exchange rate.

That is far higher than any other Council member was reimbursed for their trips to Durban. For example, the three North American Council members, besides Cesar, and their fares were:

Other reimbursements were made to Jim Blair, New Zealand (\$1891), Stan Perkins, Australia (\$1594), Jacques Serruys, Belgium (\$1300).

Perhaps there is a mistake in the figure of 39,913 French francs, since that is three to four times more than the other North American Council members spent.

Could you please recheck your figures and send another invoice accordingly?


